
Children First Trust Fund

- Allocations from the Children First Trust Fund are conditional upon the receipt of tobacco revenues.
- Multiple state agencies receive CFTF funds.
- Each agency submits a Plan of Investment to the Department of Early Childhood Education. The Department of Early Childhood Education is responsible for reporting on each fiscal year.










